Billing Information

To all NeurosurgeryOne patients:

Please note that if you are scheduled for any type of surgery or procedure, you may receive bills from several different companies. If you have any questions, please contact the company that issued the bill and not NeurosurgeryOne as we will not be able to to help you.

1. Hospital or Facility Fee:

This bill will be issued by the hospital or facility where your procedure is performed.

- > Outpatient Facilities/Surgery Centers: The facility will verify insurance benefits and contact you prior to your service to discuss the amount you will owe, which will be collected at check-in for your procedure.
- > Hospitals: Hospital stays, use of facilities and equipment, special treatments and tests, and medications are among the items for which the hospital will bill you, usually for the part not covered by Medicare or Medicaid or your private or employee insurance plan. Most NeurosurgeryOne inpatient surgeries are performed at Centura Health hospitals. You can contact Centura Health billing at 303-486-5400 (Denver metro area) or toll-free at 800-953-0104.

2. Physician Fees:

> NeurosurgeryOne: NeurosurgeryOne cannot quote an estimated patient cost. We can tell you what will be billed to your insurance, but that is NOT an accurate patient amount due to deductibles, insurance discounts, patient deductibles, and patient co-payments. If required, NeurosurgeryOne will obtain authorization for physician fees and facility fees from your insurance prior to your procedure. ALL INSURANCES are checked for authorization. 3. Anesthesia Fees:

Anesthesia services are billed directly by the provider. If you have questions, please contact the anesthesia service directly. Anesthesia services at our facilities are provided by the following, but are not limited to:

4. Additional Physician Fees:

If you require additional services from non-NSO physicians during your hospital stay or outpatient visit, you also may receive a bill for those services. These may include:

- > Radiologists will bill you for reading any X-rays that were taken while at the hospital.
- > Consulting Physicians may be asked by your treating physician to review your care for any special needs. You will receive a bill from these physicians as well.
- > Pathologists will bill you for any laboratory and pathology test(s) they have read while you were at the hospital.
- > Neuromonitoring Services are used for most inpatient neurosurgeries and bill patients directly. These services are independent of NeurosurgeryOne.
